## RESERVES

- The onus is on Clubs to ensure they use reserves who are not of a higher standard than the replaced player. Opposing teams can protest the reserve's standard in writing on the result sheet.
- It is the responsibility of the Team Captain to arrange Reserves if necessary. It is not the responsibility of the TNB Competition Co-ordinator.
- Registered players must play 3 matches, or provide a letter of explanation.

## START/FINISH TIME

- Match Start Time is **1.00/3.05pm sharp.**
- Players should be ready to commence the set – not the hit up – **at the start time.**
- If a team is not ready to play at the scheduled starting time, the other team is awarded the first sets.
- Please observe starting times.
- Finish time must be **3.00/5.05pm sharp.** This must be strictly enforced.
- Game or Tiebreaker started prior to FINISH time **MUST NOT** be completed.

## ORDER OF PLAY
