### LODGMET OF RESULTS

### MATCH RESULT

Matches shall be decided on sets then on games. If sets and games are even, the match shall be declared a tie and the three points for a win will be divided equally between the two teams.

### TIE BREAKER

The **12 point Tie Breaker** is to be played if the game score in any set reaches six games all (6-6).

### RESERVES

- The onus is on Clubs to ensure they use reserves who are not of a higher standard than the replaced player. Opposing teams can only protest the reserve's standard in writing on the result sheet.
- It is the responsibility of the Team Captain to arrange Reserves if necessary. It is not the responsibility of the TNB Competition Co-ordinator.
- Registered players must play 3 matches to qualify for the Final rounds or provide a letter of explanation
